As the owner and operator of marine transportation vessels, Transport Nanuk (the *Company*) is committed to safe and environmentally sound operating practices. In this regard, it is the Company's Policy to promote and enhance safety at sea, prevention of human injury or loss of life and avoidance of damage to the environment and to property.

In order to ensure the stated objectives, the Company has set up a Safety Management System (the *SMS*), based on the ISM Code and other applicable national and international legislation and other regulatory requirements.

Company's management will monitor, through internal audits and verification that the policy is effectively implemented. The Safety Management System will be evaluated annually in order to identify aspects to improve. All suggestions for improvement are welcome.

The company's objectives within the scope of the SMS are:

- 1. Develop, implement and maintain the standards of safety and environmental protection with prudent and reasonable practicability;
- 2. Establish that all operations carried out by its personnel, both ashore and on board, shall bear special emphasis to:
 - a. Provide a place of employment that is as safe as reasonably possible from identified risks;
 - b. Promote accident prevention and pollution prevention programs;
 - Comply with all regulations applicable to both ship and shore-based operations and other requirements such as applicable codes, guidelines, and standards recommended by Classification Societies, International Maritime Organizations and other Maritimes administrations;
 - d. Continually improve the safety management skills of shipboard and shore-based personnel, including preparing for emergencies related both to safety and environmental protection.
- 3. Continuously improving the quality of customer services;

4. Manage to actively participate in the implementation of Transport Nanuk's Safety Management System, increase efficiency and promote Company's image and reputation for quality.

The company will maintain key personnel knowledge on safety and environmental protection matters up-to-date through relevant training.

Safety, accident prevention and pollution prevention are operations related responsibilities, thus all employees, at all levels, are held responsible for using good judgment and to diligently and consistently apply the Company Guidelines and Safety Procedures in order to prevent job-related injuries and illnesses, property damage and environmental accidents.

Every employee is expected to demonstrate a positive attitude toward this policy.
